Booth locations shall be assigned by the Committee, with those first enrolled receiving preference in location. Electricity and water hookup is available at the Park. Food and concession vendors will not be duplicated, so early enrollment is advised.

All applications must be received with payment no later than Thursday, July 1, 2010. Items for sale and booth appearance must be appropriate for family audiences. Sale or possession of alcoholic beverages is prohibited. Participants agree to park vehicles in designated areas outside the park area.
